



## GENERAL PROCUREMENT NOTICE N°1 OF THE COMPACT AMENDMENT N°1

The Government of **Benin** has received grant funding of Three Hundred and Seventy-Five Million United States Dollars (USD 375,000,000) from the Millennium Challenge Corporation (“MCC”) of the United States Government to enable the Government of Benin to implement this Program and achieve the objectives of the MCC Grant (Compact II), and it intends to apply parts of the proceeds of the funds to payments for Contracts for Goods, Works and Services. The Government of Benin contribution to this Program is Twenty-eight Million, One Hundred and Twenty-Five Thousand United States Dollars (USD 28 125 000).

The procurement Plan that follows the Compact entry into force on June 22, 2017 is modified as follows:

<b>Procurement for goods</b> for the Communication and General Administration, the Electricity Generation Project (EGP), the Electricity Distribution Project (EDP) of the Program MCA-Benin II including:
<b>Communication and General Administration of the Program MCA-Benin II</b> <ul style="list-style-type: none"><li>• Acquisition of personal protective equipment for MCA-Benin II staff;</li><li>• Supply and installation of sound system equipment;</li><li>• Supply and installation of photocopiers and computer hardware and accessories;</li><li>• Supply and installation of office furniture and accessories;</li><li>• Supply of archiving equipment and furniture.</li></ul>
<b>Electricity Generation Project (EGP)</b> <ul style="list-style-type: none"><li>• Acquisition of ArcGis online + Desktop licenses;</li><li>• Acquisition of tablets with GPS - SBEE and MCA Benin II;</li><li>• Acquisition and installation of TRITEC software plus training for the Construction Project Team and the Implementing Entity - SBEE;</li><li>• Acquisition and installation of computer hardware and equipment for the benefit of the Implementing Entities;</li><li>• Acquisition and installation of communication and telecommunication equipment plus accessories for the benefit of the Implementing Entity - SBEE;</li><li>• Acquisition of 4X4 pick-up vehicles plus associated services for the benefit of the Implementing Entity;</li><li>• Acquisition of office supplies for the Implementing Entities;</li><li>• Acquisition of audio-visual equipment for the benefit of implementing entities.</li></ul>

- Recruitment of a Consultant to develop the SBEE specifications as operator/trader;
- Support to the Government of Benin in the implementation of the road map for the establishment of GENCO.
