





# GENERAL PROCUREMENT NOTICE **RELATED TO THE COMPACT PROCUREMENT PLAN N°2 AMENDMENT N°2**

The Government of Benin acting through its representative MCA-Benin II has received grant funding amounting to Three Hundred and Seventy-Five Million United States Dollars (US \$375,000,000) from the Millennium Challenge Corporation ("MCC"), an agency of the United States Government, to enable MCA-Benin II to implement the MCC Compact and achieve objectives of the Program. It intends to apply parts of the proceeds of the funds to payments for contracts for goods, works and services. The Government of Benin's contribution to the Program is Twenty-Eight Million, One Hundred and Twenty-Five Thousand United States Dollars (US \$28,125,000).

The Procurement Plan that follows the Compact's entry into force on June 22, 2017 is modified as follows:

#### Estimated value: US \$198,266,053

Covered period: April 2018 - March 2019

#### **Procurement of Goods**

Procurement of goods for the Policy Reform and Institutional Strengthening Project (PRISP), the Department of Administration and Finance (DAF) and the Electricity Generation Project (EGP) of the MCA-Benin II Compact including:

## Policy Reform and Institutional Strengthening Project (PRISP)

- Selection of equipment suppliers to establish a testing laboratory for refrigerators and lamps;
- Selection of suppliers and distributors of energy efficient products to households.

#### Department of Administration and Finance (DAF)

- Supply and installation of an electricity stabilizer (20 KVA);
- Supply and installation of CISCO phones or equivalent;
- Acquisition of office supplies and accessories.

#### **Electricity Generation Project (EGP):**

- Acquisition of ARCGIS Desktop licenses;
- Acquisition and installation of computer hardware and equipment for MCA-Benin II's Implementing Entities.

#### **Procurement of Works**

Procurement of works for the Electricity Distribution Project (EDP) and the Environmental and Social Performance (ESP) of the MCA-Benin II Compact including:

#### **Electricity Distribution Project (EDP):**

- Design and construction of the buildings to house the National Dispatch Control Center (main center and back-up center) & equipment;
- Cotonou Network Strengthening: Construction works at 161 kV and 63 kV substations (Procurement N° 1);





- Cotonou Network Strengthening: Construction works at 63 kV and MV connections (Procurement N° 2);
- Regional Network Strengthening: Construction works at 161 kV and 63 kV substations (Procurement N° 3);
- Regional Network Strengthening: Construction works of 63 kV and MV connections (Procurement N° 4).

# **Environmental and Social Performance (ESP):**

Construction of a waste treatment building and hazardous materials storage area.
