GENERAL PROCUREMENT NOTICE RELATED TO THE COMPACT PROCUREMENT PLAN N°5 AMENDMENT N°1

The Government of Benin acting through its representative - MCA-Benin II, has received grant funding amounting to Three Hundred and Seventy-Five Million United States Dollars (US \$375,000,000) from the Millennium Challenge Corporation ("MCC"), an agency of the United States Government, to enable MCA-Benin II to implement the MCC Compact and achieve the objectives. In the framework of this Program, it intends to apply parts of the proceeds of the funds to payments for contracts for goods, works and services. The Government of Benin's contribution to the Program is Twenty-Eight Million, One Hundred and Twenty-Five Thousand United States Dollars (US \$28,125,000).

This Procurement Plan N°5 that follows the Compact's entry into force on June 22, 2017 covers the period of July 2019 to June 2020. The activities that comprise the plan are as follows:

Covered period: July 2019 - June 2020

Procurement of Goods

Procurement of goods for the Policy Reform and Institutional Strengthening Project (PRISP) and Electricity Distribution Project (EDP) of the MCA-Benin II Compact including:

Policy Reform and Institutional Strengthening Project (PRISP):

- Selection of an equipment supplier to establish a testing laboratory for refrigerators and lamps;
- Acquisition and installation of automatic meteo stations at the four sites of PV solar power plants.

Electricity Distribution Project (EDP)

• Acquisition of personal protective equipment for the implementing entities.

• Technico-economic study for the choice of optimal data routing solutions across telecommunication networks on behalf of SBEE Dispatching.

Gender integration and Social Inclusion" (GSI) Department:

Selection of a Consultant for the implementation of Gender Audit recommendations.

Individual Consultants for the Policy Reform and Institutional Strengthening Project (PRISP) of the MCA-Benin II Compact including:

 Selection of individual consultants to support the activities of MCA-Benin II within the Ministry of Energy.

Procurement of Non Consultant Services

Procurement of Non Consultant Services for the Policy Reform and Institutional Strengthening Project (PRISP) of the MCA-Benin II Compact including:

- Recruitment of a provider to support MCA-Benin II in the implementation of its communication strategy in the fields of audiovisual communication, media relations and public affairs;
- Recruitment of a provider to support MCA-Benin II in the designing and printing/execution of documents and visual materials;
- Technical Assistance by METEO BENIN (National Meteorological Agency) in the framework of the acquisition and installation of four automatic stations.
