





GENERAL PROCUREMENT NOTICE RELATED TO THE COMPACT PROCUREMENT PLAN N°14 AMENDEMENT N°1

The Government of Benin acting through its representative - MCA-Benin II, has received grant funding amounting to Three Hundred and Seventy-Five Million United States Dollars (US \$375,000,000) from the Millennium Challenge Corporation ("MCC"), an agency of the United States Government, to enable MCA-Benin II to implement the MCC Compact (the "Program") and achieve its objectives. In the framework of this Program, it intends to apply part of the proceeds of the funds to payments for contracts for goods, works and services. The Government of Benin's contribution to the Program is Twenty-Eight Million One Hundred and Twenty-Five Thousand United States Dollars (US \$28,125,000).

MCC's funding is appropriated by the U.S. Congress and obligated to the Compact up-front, with no incremental or partial funding. So, when a contract is signed with an MCA Entity, money is already available to the MCA Entity and, for most contracts, invoices are paid directly to Contractors/Consultants/Suppliers by the US Treasury.

This Amendement N°1 to the Procurement Plan N°14 that follows the Compact's entry into force on June 22, 2017 covers the period of October 2021 to September 2022. The activities that comprise the plan are as follows:

Estimated value : US \$ 4,656,083

Covered period: October 1, 2021 - September 30, 2022

Procurement of Goods

Goods for the Direction of Administration and Finance (DAF) of the MCA-Benin II Compact, including:

Acquisition of goods or non-consultant services for an amount less or equal to USD 5,000 per contract, to support the projects and the administration.

Procurement of Works

Works for the Environmental and Social Performance (ESP) Department and for the Electricity Distribution Project (EDP) of the MCA-Benin II Compact, including:

The Environmental and Social Performance (ESP) Department

Design and construction of the contaminated soil burial cell at the Takon site in the town of Sakété.

Electricity Distribution Project (EDP)

- Small finishing work on the diesel tank and supply of diesel for NDCC and BUNDCC;
- Minor civil engineering works for NDCC and BUNDCC;
- Small electrical works for NDCC and BUNDCC.
