



# **GENERAL PROCUREMENT NOTICE** RELATED TO THE COMPACT PROCUREMENT PLAN N°19

The Government of Benin acting through its representative - MCA-Benin II, has received grant funding amounting to Three Hundred Ninety-one Million United States Dollars (US \$391,000,000) from the Millennium Challenge Corporation ("MCC"), an agency of the United States Government, to enable MCA-Benin II to implement the MCC Compact (the "Program") and achieve its objectives. In the framework of this Program, it intends to apply part of the proceeds of the funds to payments for contracts for goods, works and services. The Government of Benin's contribution to the Program is Thirty Million Four Hundred and Forty-Five Thousand United States Dollars (US \$30,445,000).

MCC's funding is appropriated by the U.S. Congress and obligated to the Compact up-front, with no incremental or partial funding. So, when a contract is signed with an MCA Entity, money is already available to the MCA Entity and, for most contracts, invoices are paid directly to Contractors/Consultants/Suppliers by the US Treasury.

The Procurement Plan N°19 that follows the Compact's entry into force on June 22, 2017 covers the period of January 1st 2022 to June 22nd 2023. The activities that comprise the plan include the following:

Covered period: January 1st 2022 - June 22nd 2023

- Insulation test and control equipment plus training of 10 agents from the Beninese Electric Energy Company (SBEE) in use;

 Recruitment of individual consultants for technical support and assistance to MCA-Benin II for an amount less than or equal to USD 5,000 per contract.

## **Electricity Distribution Project (EDP):**
