



# **GENERAL PROCUREMENT NOTICE** RELATED TO THE COMPACT PROCUREMENT PLAN N°7

The Government of Benin acting through its representative - MCA-Benin II, has received grant funding amounting to Three Hundred and Seventy-Five Million United States Dollars (US \$375,000,000) from the Millennium Challenge Corporation ("MCC"), an agency of the United States Government, to enable MCA-Benin II to implement the MCC Compact and achieve the objectives. In the framework of this Program, it intends to apply parts of the proceeds of the funds to payments for contracts for goods, works and services. The Government of Benin's contribution to the Program is Twenty-Eight Million, One Hundred and Twenty-Five Thousand United States Dollars (US \$28,125,000).

This Procurement Plan N°7 that follows the Compact's entry into force on June 22, 2017 covers the period of January 2020 to December 2020. The activities that comprise the plan are as follows:

### Estimated value: US \$ 2,228,500

Covered period: January 2020 - December 2020

#### **Procurement of Goods**

Procurement of goods for the Administration and Finance Direction (DAF) and the Off-grid Electricity Access Project (OGEAP) of the MCA-Benin II Compact including:

#### Administration and Finance Direction (DAF):

Acquisition of goods or non-consultant services for an amount less or equal to USD 5,000 per contract, to support the projects and the administration.

#### Off-grid Electricity Access Project (OGEAP):

Acquisition of Goods and related services for the implementation of energy efficiency measures in ten administrative buildings.

#### **Procurement of Consultant Services**

Contracts with firms for Consultant Services for the Administration and Finance Direction (DAF) and the Monitoring & Evaluation (SE) Direction of the MCA-Benin II Compact including:

#### Administration and Finance Direction (DAF):

Selection of a firm for the financial audit of the MCA-Benin II accounts.

## Monitoring & Evaluation (SE) Direction:

Selection of a consultant for the collection of indicators baseline data.

Individual Consultants for the Administration and Finance Direction (DAF) of the MCA-Benin II Compact including:

Recruitment of individual consultants for technical assistance and support to MCA-Benin II.
