



GENERAL PROCUREMENT NOTICE **RELATED TO THE COMPACT PROCUREMENT PLAN N°18**

The Government of Benin acting through its representative - MCA-Benin II, has received grant funding amounting to Three Hundred Ninety-one Million United States Dollars (US \$391,000,000) from the Millennium Challenge Corporation ("MCC"), an agency of the United States Government, to enable MCA-Benin II to implement the MCC Compact (the "Program") and achieve its objectives. In the framework of this Program, it intends to apply part of the proceeds of the funds to payments for contracts for goods, works and services. The Government of Benin's contribution to the Program is Thirty Million Four Hundred and Forty-Five Thousand United States Dollars (US \$30,445,000).

MCC's funding is appropriated by the U.S. Congress and obligated to the Compact up-front, with no incremental or partial funding. So, when a contract is signed with an MCA Entity, money is already available to the MCA Entity and, for most contracts, invoices are paid directly to Contractors/Consultants/Suppliers by the US Treasury.

The Procurement Plan N°18 that follows the Compact's entry into force on June 22, 2017 covers the period of October 1st 2022 to June 22nd 2023. The activities that comprise the plan include the following:

Estimated value: US \$ 2 414 000

Covered period: October 1st 2022 - June 22nd 2023

Procurement of Goods and related services

GOODS for the Direction of Administration and Finance (DAF) and for the Electricity Distribution Project (EDP) of the MCA-Benin II Compact, including:

Direction of Administration and Finance (DAF):

Acquisition of goods or services for an amount less than or equal to USD 5,000 per contract, in support of projects and administration.

Electricity Distribution Project (EDP)

Acquisition of 3 PowerFactory software server licenses with unlimited nodes and multiple accesses for 5 simultaneous users and 2 single licenses with assistance, maintenance and 2-year warranty.

Procurement of Consultants Services

Direction of Administration and Finance (DAF):

Recruitment of individual consultants for technical support and assistance to MCA-Benin II for an amount less than or equal to USD 5,000 per contract.

- Recruitment of a software maintenance Expert specialized in software security and the fight against cybercrime to list and set up secure procedures and systems for monitoring and maintaining the operating software, deployed under the modernized distribution network.

- Recruitment of a SCADA/DMS Expert for the capacity building of Beninese Electric Energy Company (SBEE) operators in the secure operation and management of the Gas Insulated (GIS) /Air Insulated (AIS) sub-stations built under the MCA-Benin II Program.
- Recruitment of an Expert in Underground Networks and Cable Monitoring to build the capacity of Beninese Electric Energy Company (SBEE) operators in the safe operation and management of Gas Insulated (GIS)/High Voltage (HTB) sub-stations built under the MCA-Benin II Program.
- Recruitment of an Expert in Protection and Digital Command Control (CCN) of Gas Insulated (GIS) / High Voltage (HTB) sub-stations for capacity building of Beninese Electric Energy Company (SBEE) operators in the safe operation and management of GIS/HTB sub-stations built under the MCA-Benin II Program.
- Recruitment of an Expert in the operation of Gas Insulated (GIS) / High Voltage (HTB) sub-stations to build the capacity of Beninese Electric Energy Company (SBEE) operators in the safe operation and management of GIS/HTB sub-stations built under the MCA-Benin II Program.
- Recruitment of a Telecom Expert for capacity building of Beninese Electric Energy Company (SBEE) operators in the secure operation and management of Gas Insulated (GIS) / High Voltage sub-stations built under the MCA-Benin II Program.
- Recruitment of an Expert in the operation of High/Medium/Low Voltage Power Transformers to build the capacity of Beninese Electric Energy Company (SBEE) operators in the safe operation and management of Gas Insulated (GIS) / High Voltage sub-stations built under the MCA-Benin II Program.
- Recruitment of an Environmental, Health and Safety Expert to build the capacity of Beninese Electric Energy Company (SBEE) operators in the safe operation and management of Gas Insulated (GIS) / High Voltage sub-stations built under the MCA-Benin II Program.
- Recruitment of an individual consultant for on-the-job training of 5 planning engineers from the Beninese Electric Energy Company (SBEE) + 1 from the Electrical Community of Benin (CEB) to ensure the optimization of the model of the interconnected distribution network using the PowerFactory software and the SBEE Dispatcher training simulator.


Environmental and Social Performance (ESP)

Direction of Economy, Monitoring and Evaluation

Recruitment of an individual consultant to support MCA-Benin II in the preparation of the Program completion report.

 Recruitment of an Expert for the deployment of the PowerFactory Software (installation, configuration, and commissioning).

WORKS for the Electricity Distribution Project (EDP) of the MCA-Benin II Compact, including:

Electricity Distribution Project (EDP)

- Execution of adaptation and rehabilitation works for the Beninese Electric Energy Company (SBEE) sub-stations to accommodate the new GE Scada equipment, supplied under the MCA-Benin II Program.
- Works for the reinforcement of the new sub-stations (Berlin wall, Ascena wall, construction of walls around the sub-stations and installation of barbed wire).
